2.) Team Privatization:	<ul style="list-style-type: none"> • Private Organization <ul style="list-style-type: none"> ○ Brian has been working with MWR individuals to ensure that we are meeting all requirements as an MWR Private Organization. ○ As of 1 Sept 09 FTLL will no longer fall under MWR management ○ Swimmers will no longer have to pay the MWR summer and winter fees ○ Brian met with Steve Wilburn to finalize pool hours and fees ○ FTLL will be required to rent the pool from MWR; we will be allowed to utilize the pool from 6pm to 8:30 Monday-Friday ○ Brian believes that our monthly fee will be approximately \$700.00 per month; will finalize the amount at PAIR day on Saturday • Changing fees: <ul style="list-style-type: none"> ○ Now that we are paying a rental fee for the pool each month, it will be necessary to increase monthly dues ○ Families will essentially be paying the same amount as they did when MWR sponsored us; families will not pay the MWR fees, but rather will pay an extra \$10/month to compensate for the increased pool rental expense ○ As of Sept 1, new fees will be: <u>Bronze-\$55</u> <u>Silver-\$60</u> <u>Gold-\$65</u> <u>Platinum-\$75</u> ○ As of Sept 1, new multiple swimmer discounts are: <table style="margin-left: 20px; border: none;"> <tr> <td>2 swimmers—10% off of total cost</td> <td>3 swimmers—15% off of total cost</td> </tr> <tr> <td>4 swimmers—20% off of total cost</td> <td>5 swimmers—25% off of total cost</td> </tr> </table> 	2 swimmers—10% off of total cost	3 swimmers—15% off of total cost	4 swimmers—20% off of total cost	5 swimmers—25% off of total cost
